WAGGS BED & BREAKFAST TERMS & CONDITIONS

Waggs Bed & Breakfast aim to provide a relaxing, fun and enjoyable experience for your dog and treat each animal with the respect and kindness they deserve. We will contact you immediately if there is an incident or if your dog has any need for veterinary attention. We advise that Waggs Bed & Breakfast works in accordance with the current Animal Welfare Code of Practice for Home Boarding Establishments and at all times will endeavor to provide safe, clean and secure accommodation for your dog.

To assist us with achieving the highest possible standard of care for your dog, we advise that your consent to the following Terms & Conditions is a strict requirement of entry. Please take the time to read the Terms & Conditions and sign your name where indicated at the bottom.

1. By signing these Terms & Conditions, the owner confirms the accuracy of all information given about the pet. It is acknowledged that upon the signing of this document a contract shall arise which shall create a lien over the animal in favour of Waggs Bed & Breakfast, which lien shall continue to exist whilst ever monies are owing pursuant to the contract and these Terms & Conditions.
2. The owner warrants that the pet is older than 4 months of age with completed updated vaccinations. All dogs need to have a C5 vaccination at least 14 days or more prior to boarding.
3. Waggs Bed & Breakfast reserves the right to refuse entry of any animal.
4. A non-refundable 50% deposit is required to secure the booking. Balance is payable on completion of service, including any additional fees incurred.
5. Waggs Bed & Breakfast is a working farm and dogs may experience exposure to goats, donkeys, chickens and other livestock. The pet owner is solely responsible for any and all acts or behavior of the pet. Dogs must be on a lead upon entering or exiting Waggs Bed & Breakfast.
6. The owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
7. If veterinary attention is necessary for the pet, the owner is liable for all such expenses. Waggs Bed & Breakfast will endeavor to contact the Owner or Emergency Contact if such attention is required, however if the owner or contact is uncontactable, the owner agrees that Waggs Bed & Breakfast may make decisions on their behalf with respect to the best interests of the dog. Travel costs to and from the vet will be applied in which case the owner will be required to pay to Waggs Bed & Breakfast. All vet fees will be required to be paid directly to the vet or reimbursed to Waggs Bed & Breakfast - whichever is applicable.
8. Medication is administered free of additional fees and will only be administered if medication is supplied in original packaging from a vet with proper dosage instructions. Dogs presenting with worms or fleas will be given appropriate treatment at the owner's expense.
9. Dogs are fed once per day, unless otherwise instructed by pet owner.
10. The pet will be delivered to any person who is prepared to declare that they have the owner's authority to do so, unless otherwise instructed in writing.
11. The owner may leave the pet's favorite toys, blankets and other comfort items which must be clean and disinfected before arrival. Waggs Bed & Breakfast will not be responsible for any such items lost, destroyed or left behind. All items must be clearly labelled.
12. If in the event that a dog damages furniture, bedding or any part of the Waggs home, owners may be charged for the damage incurred.
13. Waggs is a home boarding establishment (NOT A KENNEL) and dogs are considered part of the everyday activities which includes accommodation and play with other dogs both resident and in boarding. All reasonable care and precautions are followed, and the owner hereby releases Waggs Bed & Breakfast from any liability of any kind whatsoever arising from the dog's attendance and participation in everyday activities including play with other dogs at Waggs.
14. All drop off and pick-up times are by appointment only. The facility is otherwise closed to the public and entry without an appointment is not possible.
15. Waggs Bed & Breakfast will take reasonable precautions to prevent the theft of pets during their stay however Waggs Bed & Breakfast disclaims any and all liability should a theft occur.
16. Boarding rates are charged on a calendar day basis per the fees on the website. The owner agrees to pay the rate for boarding that is in effect on the date that the pet is checked into Waggs Bed & Breakfast. All prices (refer to website) are per day and are calculated by the day for any dogs dropped off prior to 4.30pm or picked up after 10am. All fees are subject to change without notice.
17. All outstanding fees and charges incurred by the pet owner will be processed by Waggs Bed & Breakfast by cash or direct deposit at the conclusion of the stay unless other payment arrangements have been previously agreed upon.
18. In the event of the dog not being picked up from Waggs Bed & Breakfast on the agreed date, or if all charges are not paid on completion of the boarding, Waggs Bed & Breakfast has the right to offer the pet for public sale. If such a sale does not secure a price adequate to cover the charges and the cost of sale, the pet owner is liable to Waggs Bed & Breakfast for the difference. Waggs Bed & Breakfast may take this course of action if not advised of a pick-up date within two (2) weeks of the intended pick-up date.
19. The owner releases and indemnifies Waggs Bed & Breakfast and its employees or agents from all liability for injury, death, loss or damage of any kind whatsoever that may occur to any dog in the care of or staying at Waggs Bed & Breakfast including injury or death while under the supervision of Waggs Bed & Breakfast, its staff or its agents.

21. Signing and agreeing to these terms and conditions covers the initial booking and all future bookings. I have read, understood and agree to the above terms and conditions.
