If your pet should become ill, I reserve the right at my discretion to call a veterinarian administer prescribed aid or place the animal in the care of a veterinarian. Any expenses incurred will be the total responsibility of the owner. The owner will be notified as soon as possible. Every effort will be made for the dog to be seen by your nominated veterinarian however I reserve the right to take your animal to the closest veterinarian if emergency treatment is required.

WAGGS - houses more than one dog at a time, the dogs are not confined on their own inside or outside hence if conflict occurs between two animals the owners will be contacted immediately for alternative care to be arranged. Every effort is made to prevent conflict.

The owner agrees to pay all costs during and relating to the dog(s) stay at WAGGS B & B including daily boarding fees, veterinary expenses and special services requested and other related costs on picking up the dog(s) from WAGGS B & B.
